- Jeff Kunzer would like to have a work day on Saturday June 18<sup>th</sup> starting at around 7:00AM. Primarily to clear brush, limbs and other obstructions that interfere with mowing. Also removing stones and rocks around the backstop berms that could cause a ricochet and the bullet leaving the club property.

This activity counts as your volunteer time towards your annual membership dues reduction. Important too, to keep the club property looking good and also makes mowing a much easier task. Another important benefit is eliminating places where deer ticks sit in waiting for a body to pass by. Keep this in mind to everyone mowing brushy areas where you mow.

- Piles of road grindings may appear in the east end of the parking lot. Will be used to spread on the parking lot. More economical than crushed stone.
- Steve Benedict suggested having a Defibrillator available in the clubhouse as a safety measure. Much discussion ensued including the requirement that it has to be administered by someone trained to use one and the liability if used incorrectly. An alternate suggestion was training members in CPR.
